

PACIFIC WEST

Terms and Conditions:

1. The "FOODball FEVER CONTEST" ("Contest") is organised by Pacific West Foods (M) Sdn Bhd ("Organiser").
2. This Contest shall commence from 16th April 2018 till 15th July 2018 ("Contest Period").
3. The Organiser reserves the right to modify, postpone, re-schedule and/or extend the Contest Period and/or cancel/terminate the Contest at any time without giving prior notice.
4. This Contest is open to all residents and permanent residents of Malaysia, currently residing in Malaysia, aged 18 years old and above. ("Participants")
5. The representatives, employees, servants and/or agents of the Organiser (including their respective affiliated and associate companies) and their immediate family members are not eligible to participate in this Contest.
6. The Organiser reserves the right to exclude and/or disqualify Participants who do not fall within the category of Participants and/or who are in breach of the Contest Rules and Regulations.

9. Submission of Entries by Post
All entry form(s) must be completed legibly and attached together with the original single printed receipt as a Proof-of-Purchase ("POP"), delivered as ordinary mail. Any other means of delivery will be automatically disqualified. The Organiser will not be responsible for any non-receipt of postal deliveries. Proof of postage is not proof of receipt.
10. Submission of Entries through Pacific West On-Ground Road shows
Entry form(s) must be completed legibly and attached together with the original POP receipt for submission of entries through Pacific West on-ground road shows.
11. Multiple entries will be accepted, provided they are attached with a valid POP receipt. Each POP receipt can be submitted only ONCE. Illegible entries with defaced POP receipts will be automatically disqualified.
12. All entry forms received by the Organiser during the Contest period that are complete, if approved by the Organiser, will be serialised according to the POP Table based on the POP submitted [each a "Qualified Entry" and collectively the "Qualified Entries"].
